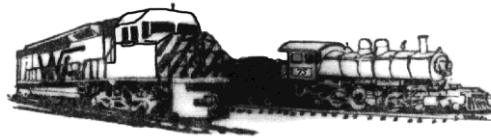

We have scheduled this event for Sunday, **October 12th 2025**. We continue to hold this event at the Washington County Fair Park which is located minutes from Milwaukee at 3000 Pleasant Valley Road (Hwy PV), West Bend, WI 53095. The park is visible from US Highway 45 and there is a ramp for County Highway PV. **For 2025 the show will be back in the Zeigler Family Expo Center**. The event will run from 9:00 a.m. to 3:00 p.m. Dealers and exhibitors may begin early set-up at 11am Saturday, otherwise day of at 6:30 a.m Sunday. Move in help will be available. There is easy access to the facility, including a garage door entrance on the sides, as well as plenty of parking. This show is for all scales of model railroading and for railroad related memorabilia.

The table rental fee is \$20.00 for each table. All tables are eight feet in length. Tables are available on a first reserved – first served basis. We expect to sell 180-200 tables in 2025.
